Our Access and Information Line

Alliance offers live support by qualified professionals 24 hours a day, 365 days a year at **(800) 510-9132**.

- + Brief telephone screening to determine if services are needed
- + Crisis help by telephone or to arrange for an emergency face-to-face meeting with a professional
- + Information on community resources and supports
- + Referral to Alliance’s local network of providers

Accessing the Provider Network and Preparing for Your First Appointment

Alliance Health works with a network of providers in our communities to ensure that the right kinds of high-quality services are available for the citizens of Durham, Wake, Cumberland and Johnston counties. Our network includes independent providers, provider agencies, and hospitals and other facilities.

Preparing for Your First Appointment

- + List of current prescription and over-the-counter medications**
- + List of programs you've attended, including dates**
- + List of hospitalizations, including dates**
- + Your Medicaid ID card and other insurance card, if applicable**

What to Ask

- + What is my most important medical concern?**
- + What do I need to do first?**
- + How will this help improve my health?**
- + When should I follow up with your office?**

Crisis and Assessment Centers

If you feel that you are in a mental health or substance use crisis, you can come directly to a Crisis and Assessment Center. Or, you can call Alliance Health at **(800) 510-9132** and we can help you figure out what to do next.

If you need help right away, we will work with you to find the right option for you. All of the Crisis and Assessment Centers can provide help in getting you past your crisis. Durham, Wake and Cumberland counties also provide a different option than being admitted to a hospital.
